### Board Member Qualifications

- Must be at least 18 years of age *\*honorary members excluded from age requirement*
- Committed to actively supporting IOYS and the LGBTQIA2+ community, with a strong dedication to diversity, equity, inclusion, and justice—especially for young people at the intersections of multiple marginalized identities.
- Available to attend meetings and events (see below)
- Prior board or non-profit experience not required

### What Board Members Do

- Serve a three-year term
- Attend at least 10 of 12 monthly board meetings having reviewed materials in advance (currently scheduled for 4<sup>th</sup> Wednesday of each month, 5-6:30 pm)
- Support the annual fundraising event, including inviting guests and assisting with outreach
- Attend at least one IOYS event per year (e.g., Queer Prom, Bacchus, Gratitude Dinner, Pride Inside and Out)

- Actively participate and serve as board liaison in at least one committee (80% attendance required)
- Participate in DEIJ (Diversity, Equity, Inclusion, and Justice) focused training or development opportunity annually to apply equity and justice principles within your board capacity.
- Represent IOYS as an ambassador in your networks and help identify future board, committee, and philanthropic partners
- Contribute skills, perspectives, and knowledge to support organizational growth

### Financial Commitment

- Set a personal fundraising (“get”) goal each year, which may include personal giving, in-kind donations, peer-to-peer fundraising, or corporate matches)
- 100% board giving participation is expected (any amount – even \$1)

### Board Committees

***Committees are comprised of board members, volunteers, staff members, and community partners. If you’re new to IOYS or non-profits, we encourage you to join a committee before applying to join the Board.***

- **Events/Development:** Fundraising & event planning (1<sup>st</sup> Fri, 1-2 PM)
- **Finance:** Budget oversight & audit (3<sup>rd</sup> Wed, 4-5 PM)
- **Governance:** Policies & compliance (1<sup>st</sup> Tues, 4:30-5:30 PM)
- **DEIJ:** Integrating diversity, equity, inclusion, & justice (meeting time TBD)
- **Policy & Advocacy:** Tracks LGBTQIA2+ legislation, works to advance protections (3<sup>rd</sup> Fri, 12- PM)
- **Recruitment:** Assists in recruiting & evaluating board/committee members (Meets as needed)
- **Strategic Planning:** Long term IOYS strategic goal setting/tracking (4<sup>th</sup> Mon every other month, 4-5 PM)
